Thank you for considering a gift to help people with spinal cord injury as part of your legacy.

If you have an existing Will you can easily add support for people with spinal cord injury to your legacy by applying a Codicil to your existing Will.

For your convenience we have included Codicil language examples below. Simply insert your preference the underlined space. While it is true that a Codicil is an easy way to add to your legacy, and if hand-written they don't require witnesses, reviewing your options with someone knowledgeable is always a good way to make certain your tax savings are optimized, and your legacy goals are achieved.

- consider adding the clause: "In the event that circumstances make the specific use of this
 gift no longer practical or desirable, the Board of Directors of Spinal Cord Injury Ontario
 are hereby authorized to make changes in its use which remain in agreement with the
 spirit and general intent of my legacy."
