

Building Capacity in Long-term Care National Occupational Standard

Project Introduction

The <u>Building Capacity in Long-term Care project</u>ⁱ is a national initiative to address the acute labour shortages in the long-term care sector exacerbated by the COVID-19 pandemic. It is funded by the Government of Canada's Sectoral Initiatives Programⁱⁱ.

CICan is working with its members, provinces and territories, employers, workers' organizations, and other stakeholders to create a national occupational standard (NOS) for personal care providers (PCP)ⁱⁱⁱ. This standard will serve as a base line and reference point to help employees, employers, and educators understand what workers need to know to succeed in different roles.

In Canada, there is no national standard for the profession, for the training or regulatory monitoring for PCPs. IV Health care and education is under the purview of the provinces making the development of national standards challenging. The scope of practice varies widely across the country and there is a range of occupational titles and roles. There is interest in the development of standards in some regions. For example, Alberta recently added Health Care Aides to regulated professions under the Health Professionals Act. But, for now, only five provinces (Alberta, British Columbia, Nova Scotia, Ontario, and Québec) and one territory (Yukon) have a mandated health care aide/personal support worker educational curriculum Also, most of the work that has been done pertains to education and standards of care aimed at employers are now also in development Inivition.

What is a national occupational standard?

A national occupational standard describes the skills, knowledge, and abilities required to perform the duties of a profession effectively, competently, and successfully. It serves as a point of reference and provides a comprehensive definition of what it means to work in a specific occupation.

Why are national occupational standards created?

Standards are established for a wide range of professions and help employers, job seekers, workers, students, and educators make informed decisions about hiring, skills training, and career choices. They also form the basis of a national educational standard and can help reduce skills gaps.

Advantages of a national occupational standard

- Workers are better able to plan and prepare for a career path
- Employers can focus on recruiting the right workers with the necessary skills
- Educators can create a curriculum based on clear, consistent training requirements



How will a National Occupational Standard deal with variances, and duplications?

As in any other NOS, we are setting the minimum entrance standard across Canada. This first step will keep it simple by developing a national base line. Jurisdictional variances and specializations will be added and integrated as a next step once this first step of reaching a basic national occupational standard is completed.

Cultural safety and humility to foster inclusion

Cultural safety, humility, and inclusion will not be listed as separate competencies. They will be woven into every task of the occupation^{ix} to incorporate an intersectional lens into quality across the health care system and to foster quality care that is safe and appropriate for all peoples^x.

- Cultural safety is an outcome based on respectful engagement that recognizes and strives
 to address power imbalances inherent in the health care system. It results in an
 environment free of racism and discrimination, where people feel safe when receiving health
 care.
- Cultural humility is a process of self-reflection to understand personal and systemic biases and to develop and maintain respectful processes and relationships based on mutual trust.
 Cultural humility involves humbly acknowledging oneself as a learner when it comes to understanding another's experience.
- Inclusion refers to how diversity is leveraged to create a fair, equitable, healthy, and highperforming organization or community where all individuals are respected, feel engaged and motivated, and their contributions toward meeting organizational and societal goals are valued^{xi}.

The choice of terminology – Personal care provider (PCP)

Over 1300 hours of work has been invested into defining the work and terminology before this phase of the project commenced.

For example, due to variances across provinces and territories, a consensus was reached in terms of nomenclature for positions in the long-term care sector. For this project, **personal care provider (PCP)** to refer to a number of titles including:

- health care aide
- continuing care assistant
- personal support worker
- home support worker
- personal care attendant
- home care worker
- continuing care worker
- residential care worker



home care assistant

We are further proposing that "personal care provider" be the overarching occupation name used in the national occupational standard as it is not used as a role title in any jurisdiction.
